**TO THE HONORABLE MEMBERS OF THE COMMON COUNCIL OF THE CITY OF WHITE PLAINS**

Included in the FY 2022-23 Capital Improvement Program, adopted by the Capital Projects Board, is a project entitled “Gillie Basketball and Park Improvements” at an estimated cost of \$90,000. The project is the responsibility of the Commissioner of Public Works and includes improvements to the parking lot and walkways; basketball court play area; tennis spectator area; and replacement of a retaining wall. Submitted herewith is legislation which authorizes the Commissioner Public Works to enter into various purchase orders and contracts as required to complete the project.

The legislation also authorizes the Mayor to direct the Budget Director to amend the Capital Projects Fund by establishing Capital Project No.C5607 entitled “**Gillie Park Improvements FY23**” as follows:

It is further requested that issuance of \$91,000 in serial bonds be authorized and the Mayor be authorized to direct the Commissioner of Finance to advance funds from the General Fund to this project, pending the receipt of the bond proceeds. Finally, it is requested that the Mayor be authorized to direct the Commissioner of Finance to receive and disburse funds accordingly
